Charity Chan (she/they) has been an arts professional for over 25-years, working across Canada, the United States, Latin America, and Europe. Having served as the Interim Associate Dean of Music and Fine Art at Humber College and the Head of Public Programmes and Learning at the Museum of Contemporary Art Toronto, she has also overseen the annual performing arts season at the Aga Khan Museum of 250+ programs, and currently oversees outreach and communications for Luminato Festival Toronto's Edward Burtynsky Immersive Exhibition "In the Wake of Progress." Charity holds an M.F.A. in Contemporary Performance and Literature from Mills College, and was previously an Andrew Mellon Fellow at the Centre for Arts and Cultural Policy at Princeton University and a Perkins Fellow at Columbia College Chicago's Centre for Black Music Research.

She has multiple years of experience in fundraising and arts administration, with additional experience in management, customer service, and hospitality.
